Lynne Hall, RN, BSN, works as the Quality Improvement Specialist for the Georgia Hospital Association (GHA). In this role, she coaches and assists participating hospitals to implement evidence-based practices to reduce preventable harm and reduce readmission using selected performance improvement strategies and serves as the contact to facilitate additional coaching. Lynne provides assistance in deploying technical assistance related to understanding the various reports that will be provided to hospitals and assist them in determining process measure for rapid change improvements.

Ms. Hall has been instrumental in coordinating the PHA Eliminating Preventable Harm (EPH) state initiative by collaborating with hospitals and coordinating data management. She has knowledge and experience in clinical data and analysis. She facilitates the Adverse Drug Events with the AHA HRET HIIN. Lynne is also skilled in abstracting and teaching CMS quality improvement initiatives with in-person group meetings as well as one-on-one training. Lynne has conducted educational workshops and conferences via telnet and face-to-face meetings related to Core Measures, ADE events, and works closely with GHA Government Relations who work with the Georgia Attorney General Opioid Task Force. Along with two Bachelor's Degrees (Child development and nursing), she has her Black Belt in Lean/Six Sigma, Reliable Systems Process Design, and is a Master TeamSTEPS trainer.
