

# Contracted Services: Ensuring Compliance with the CMS Hospital CoP Standards, Joint Commission and DNV

## Program Overview

Contracts have become a recent hot topic with increased scrutiny by both the Joint Commission (TJC) and CMS. This presentation will cover all of the contract requirements for hospitals accredited by TJC. The CMS telemedicine standard also updated a section in TJC's contract standards, covered in the TJC contract tracer. The program will also cover the standards for hospitals accredited by DNV-GL.

The webinar will include the CMS hospital condition of participation requirements for contracts. Every hospital that accepts Medicare or Medicaid reimbursement must follow the CMS contract regulations and interpretive guidelines. CMS has also added a section to the final CMS worksheets to ensure the surveyors addresses the contract management issue.

## Program Objectives

- Discuss the contract standard in the Joint Commission leadership chapter
- Discuss the section in the CMS hospital conditions of participation that sets forth requirements for contracted services
- Explain how the same level of care is required whether the hospital provides the services directly or through contracted services
- Identify the CMS requirement that explains how the Board has to make sure contract services are reviewed as part of the QAPI process
- Explain how hospitals accredited by DNV must also follow their contract management standards
